TERMS AND CONDITIONS

I. PROMOTION DESCRIPTION

The *MONEYGRAM IDOL AWARDS* is a promotion aimed to pay tribute to our modern day hero, the overseas Filipino worker, and their immediate families (“Promotion”).

II. PROMOTION DURATION

1. The Promotion duration is from January 8, 2018 to April 15, 2018, both days included (“Promotion Period”)
2. Last day of submission of entries is at 11:59 p.m. of April 15, 2018.

III. WHO CAN JOIN:

1. Any Filipino citizen, 18 years old and above, who is a recipient of an international remittance transaction from an overseas Filipino worker family member (“International Transaction Recipient(s)”).
 2. Any Philippine citizen, 18 years old and above, who is a recipient of a MoneyGram transaction from an overseas Filipino worker family member* (“MoneyGram Transaction Recipient(s)”).
- *including migrants*

IV. MECHANICS:

1. To participate, International Remittance Transaction Recipients and MoneyGram Transaction Recipients in the Philippines (“Recipients”) need to access the Internet and log on to <http://global.moneygram.com/ph>.
2. Charges that may occur for accessing the Internet will be for the account of the Recipient.
3. Only entries and remittance transactions received during the Promotion Period will be eligible to participate.
4. International Transaction and MoneyGram Recipients must log in the MONEYGRAM site, and key in the following:
 - i. Full name
 - ii. Age
 - iii. Home/Postal Address
 - iv. Mobile number
 - v. Email address
 - vi. Indicate region where the sender is from (drop down option to be provided)
 - vii. Date of remittance transaction
 - viii. Last five (5) digits of the remittance transaction.

5. MoneyGram Transaction Recipients may use the last 5-digit MONEYGRAM transaction only once.
6. For MONEYGRAM transactions, MoneyGram Transfer Recipient's entry entitles them to two entries, increasing their chances of winning.
7. All Recipients receive the following message after a successful registration: *"Thank you, you have one entry!"*
8. MoneyGram Transfer Recipients can register more than once using different transactions. More entries give the customer more chances of winning.

V. **DRAWS AND NOTIFICATION**

1. An electronic raffle will be held at the MONEYGRAM office located at Suite 1501-1502, Level 15, Tower One, Ayala Avenue, Makati City, witnessed by representatives from MONEYGRAM, MEC agency, and DTI, on **April 17, 2018 (TBC)** to determine the following:
 - i. Twenty-five (25) consolation winners of Five Thousand Philippine Pesos each (PHP5,000.00).
 - ii.  3. Winners will be notified through the following:
 - i. Registered mail sent to the winner's postal address that was provided during the registration.
 - ii. A phone call made by the Producer's representative.
 - iii. An email sent out by a Producer's representative.
 - iv. Announcement on MONEYGRAM's Facebook page
 4. The cash prizes for all the winners will be sent by MONEYGRAM directly to the winner's home/postal address.
 5. The winners will have to present two (2) valid government IDs to the MoneyGram courier before the cash prize is released.
 6. In the absence of the required valid government IDs, winner will have to secure their IDs before proceeding to the nearest MoneyGram agent location near their location to claim their prize.
 7. The winners may be required to take part in publicity related to the Promotion including, but not limited to, having his or her photograph taken and his or her name, nationality and country of residence being disclosed.

VI. PRIZES

Neither the Producer nor any other person or party associated with the Promotion shall be liable for any loss nor damage (including but not limited to indirect or consequential loss or damage) suffered or sustained in connection with either participation in this Promotion or with the prizes offered.
4. The Producer reserves the right to amend these Terms and Conditions or to cancel, alter or amend the Promotion at any stage if deemed necessary in its opinion or if circumstances arise outside of its control.
5. These Terms and Conditions supersede all other prior terms and conditions, understandings, arrangements or agreements, whether verbal or written, in relation to the Promotion.
