GCash & MoneyGram Dream Vacation (Christmas and New Year Lucky Raffle Draw) Promotion Terms & Conditions

The "GCash/MoneyGram Christmas and New Year Lucky Draw" Promotion ("**Promotion**") is organized in the Philippines by GCash having its address at W Global Center 30th Street, 9th Avenue, Bonifacio Global City, Taguig, Philippines ("**Promoter**"). It's Partner (MoneyGram) will assist in marketing and promoting this promotion.

- 1. The Promotion is open to GCash app users who are Know Your Customer (KYC) verified and legal residents of Philippines aged 18 or over, excluding the following:
 - Employees (and family members up to 3rd degree of consanguinity), affiliates, subsidiary companies and representatives of the Promoter and Partner;
 - Agents of the Promoter and Partner including their affiliates and subsidiary companies as well as family members;
